## Chartered Accountant – Common Proficiency Test (CA CPT June 2018)

Chartered Accountant - Common Proficiency Test (CPT) is conducted for candidates who wish to pursue a career in Chartered Accountancy. This examination, commonly known as CA CPT is an entry level test conducted by Institute of Chartered Accountants of India. CA CPT is conducted twice every year i.e., in June and December respectively. It is an offline mode examination conducted in two sessions/parts .

### Eligibility Criteria:

- A candidate shall be eligible to appear in Common Proficiency Test scheduled to be held in June, 2018, if he/she has:
  - i) Either passed or appeared in the Senior Secondary Examination (10+2 examination) conducted by an examining body constituted by law in India or an examination recognized by the Central Government as equivalent thereto and has complied with such requirements as may be specified by the Council from time to time and
  - ii) Registered for/switched over to Common Proficiency Course with Board of Studies of ICAI on or before 30th June, 2017 and
  - iii) Revalidated his/her registration to Common Proficiency Course (as applicable):

**Note:** As decided by the Council, the registration to the Common Proficiency Course is valid for a period of 3 years and the student is required to revalidate the same from the concerned Regional Office on expiry of the said period. Further, in order to be eligible for the examination, the student must be having a valid Registration number on the date of application to the Examination. Accordingly, please ensure that your Registration for the Common Proficiency Course is valid as on date of filling Examination Application Form.

### Application Procedure:

- Visit the official website of ICAI (Link : <http://icaiaexam.icaai.org/index1.php> )
- Register with valid details to create CA CPT account
- Login to fill in the application form of CA CPT with your valid user ID & password
- Remit the application fee for CA CPT in online mode using Debit Card/Credit Card/Net Banking and get a print copy of fee receipt
- Take a print out of the filled in application form
- Affix recent passport size colour photograph and signature at the designated places on the printed out application form
- Get the form attested by Principal/Member of the Institute/gazetted officer as per the instructions given on the form.
- Submit the printed application form of CA CPT via registered or speed only or in person at the official address as mentioned in this document

**Application Fee:** 1000 INR (for examination centres in India only)
